Although we are aware of the Government Schools not engaging in formal exams, we were able to complete the required curriculum because we can be back at school with a 100% attendance each day. Please receive the arrangements for Grade 4 to 9 with this communication. We strongly feel that it will add value to conduct a formal assessment at this time of the year. The Pre-School and Foundation Phase will conduct their continuous assessment as they always do.

We want to thank parents who support us in complying with Covid Protocols and keeping the school safe. When any member of your family was in close contact to a positive Covid case, the rest of the family will be secondary contacts but it is safer to isolate in the best interest of the community and preventing the spreading of the virus. God has been good and although Atteridgeville is a hotspot, the number of Covid infections in our direct PEPPS Motheong community is low. We notice that learners started to experience Covid fatigue in the way they social distance and wear their masks. We had to tighten up discipline in this area. When a learner receives a reminder for not following protocols it is to keep everybody safe. Please support us in this important matter. Keep safe by making sure that you are not a close contact to any person who could possibly be asymptomatic or confirmed Covid positive. This is why we wear a mask, sanitise hands regularly, keep a safe distance and keep our buildings well ventilated
