Learners will receive a printed petition today. We request parents to read through the document and sign it if they agree. It is regarding the matter of the land issue. The land was donated to the PEPPS Trust by the municipality many years ago but we still do not have a document available to facilitate the application of a loan, which we will need for the building of the High School. We need to start with the building of the High School before the middle of the year as to have classrooms available in 2022. The Counsellor for Atteridgeville, Thabang Magodiello, suggested that we provide him with a petition before the next City Council meeting on 26 March as to submit our petition to the City Council.
